2024 Camdenton Area Chamber of Commerce Holiday Shop Hop Details & Registration

Join us for the annual Holiday Shop Hop, hosted by the Camdenton Area Chamber, from November 15th to December 16th! This festive event is designed to support our small business community. All members of the Camdenton Area Chamber of Commerce are invited to participate, regardless of their business location. Let's come together to celebrate local shopping and create a vibrant holiday spirit!

Shop Hop Window poster and Shop Hop Cards: During the week of November 11th, a chamber staff and/or volunteer will visit your business with the holiday-themed Shop Hop image poster and Shop Hop cards. Please display both items somewhere visible to the general public (ie. Front door/ front window, etc.); this is how people will know that you are participating in the Camdenton Chamber Holiday Shop Hop. You will receive a supply of tickets/cards with an instruction sheet when the Holiday Shop Hop poster is dropped off at your business. Consumer Participation of the Shop Hop is FREE therefore the tickets can be made available to everyone who visits your business. You will initial or stamp the sheet next to your business name to show that they visited your place of business. All participating businesses will be distributing the tickets so please know the consumer participant may get their ticket somewhere else. If they already have a ticket, you will initial or stamp it, just like you did for the ones distributed from your place of business.

<u>Time Frame</u>: The Holiday Shop Hop will kick-off on Friday, November 15th, 2024, which is the day before rifle season (think wives of hunters) and will run until December 16th, 2024.

<u>Prizes:</u> Tickets must be turned in at the Camdenton Area Chamber of Commerce **on or before December 16**th, **2024** to be included within the drawings. Gift Certificate prizes will be eligible to redeem at any of the participating business locations. To be eligible for the Grand Prize of a \$300 Gift Certificate all participating locations must have been visited and ticket be fully completed. The remaining tickets not fully completed (as well as those non-winning fully completed tickets) will then go into a drawing for the following prizes: 3 - \$100; 3 \$50.

Redeeming gift certificates: The gift certificates will be issued in \$25 increments by the Camdenton Chamber of Commerce and can be used at any of the businesses who are participating in the Holiday Shop Hop. If a customer chooses to spend their gift certificate(s) at your place of business, you can give them the merchandise (or service) and take the gift certificate in payment. You then will redeem that gift certificate for cash at the Camdenton Area Chamber of Commerce office. Deadline for the business to redeem gift certificates for cash is January 24th, 2025. Note: The gift certificate is redeemable by the customer for SERVICE OR MERCHANDISE ONLY and not redeemable for cash. All certificates will be in \$25.00 increments.

Cost/Eligibility for Business to Participate: To be included as a participating business, the business must be a member of the Camdenton Area Chamber of Commerce (in good standing) and then pay a participation fee (minimum of \$25) to support this shopping and branding initiative. Cash/Check (*Make payable to the Camdenton Area Chamber of Commerce*) and will need to be paid by November 5th, 2024.
